Superintendent's Report

Item A-3 Contracts List

Mr. Womack pulled the Contracts List to speak to the agreement with the City of Lodi for School Resource Officers. He questioned if the duties of the SROs lean away from enforcement to a support focus. He asked for more information regarding the second contract item, Amplify Education, Inc. Lisa Kotowski, Assistant Superintendent, Curriculum and Instruction, explained that Amplify Education, Inc. provides the means for electronic assessments for K-2 students, above the normal assessments and includes the licensing for DIBELS.

Mr. Neely inquired as to the School Resource Officers, as many districts don't pay police to be on their campuses. He noted that the City of Lodi police officers are within the city limits and are here to serve the residents of Lodi, thus this should be part of their job. He feels the \$300,000 could be used for other things. For those reasons he would not support the Contracts List agenda item.

Report

College Readiness Block Grant: Recommendation to Contract with Naviance

Dr. Washer and Mr. Hern reported that counseling staff and administration are recommending that the District contract with Naviance and they are hoping that the program can began benefitting students this year. They explained that Naviance is a tool for counselors, students, parents and teachers. It provides goal setting, college planning, career surveys, sample college prep tests, scholarship resources and ways for students to develop long-term pathways to career options. The program can be used by students and parents at home and provides lessons for teachers and counselors geared towards students planning for their future. The cost is \$14.20 per student, per year. The District's 9-12 population would be approximately \$660,000 over the life of the contract. A proposal for the remainder of the grant dollars would be forthcoming. Discussion ensued. Mr. Hern noted there is a back-out clause in the contract, so if grant dollars where to dry up, the District would not be held to finish the term of the contract.
