#### **Action Item**

#### **Resolution 2020-69 Sufficiency of Instructional Materials**

Robert Sahli, Assistant Superintendent, Curriculum/Instruction/Assessment, stated Resolution 2020-69 is required to declare the District's sufficiency of instructional materials in the core areas of math, science, social science and reading/language arts, per the Williams Settlement. He further explained that the San Joaquin County Office of Education (SJCOE) visits select school sites: 20 elementary schools, 2 middle schools, and 1 high school. In 2013 the 23 selected school sites became a permanent cohort. Each year the SJCOE conducts site visits to insure sufficient textbooks and instructional materials are available at home and in class. Dr. Sahli stated due to COVID-19, the SJCOE site visits have been suspended, but with administrator communication all textbook and instructional materials needs have been met.
