Superintendent Washer congratulated Mrs. Macfarlane on her election as president for the 2022 term and recognized the other newly appointed Board officers. She thanked Mr. Freitas for his presidential year and leadership during such a challenging time. She spoke about the school start time report that will be brought to the Board in January. Dr. Washer thanked the Board members who participated in the red-carpet event premiering Joey Travolta's, Film Camp movie "Lost Luggage".

Mr. Heberle stated the resolution was well written and he is in favor of it. He added that he is against mask and vaccine mandates.

Mr. Neely stated he is in support of the resolution and believes in vaccines; however, he does not believe it should be a mandate.

Mr. Freitas stated he is in support of the resolution and looks forward to voting on it in January.

Mr. Knackstedt stated he is in support because it is a reasonable compromise.

Mr. Porter stated he is not in favor of the resolution and will not support it. He stated he will follow what the county health department says to do and will follow the mandate. He suggested the public go to the county supervisors to try and make a difference.

Mr. Nava stated he is in favor of the resolution and does not agree with mandates and it should be a choice.

President Macfarlane stated she is in favor of the mandate.
