Comments from Employee Group Representatives

Belinda Yeats, President, California School Employees Association, Lodi, Chapter #77, spoke about the record-breaking heat wave and stated that CSEA classified employees are hard at work in the outside heat. She thanked Mr. Kahn and staff for following the proper procedures to keep staff safe during the high temperatures.

Lisa Wilkins, President, Lodi Education Association, listed off the schools throughout the District that had issues with air conditioning during the heat wave.

Comments from the Board

Mr. Knackstedt spoke about the College and Career Night and how well attended it was. He asked if San Joaquin Delta College classes are articulated with Lodi District classes.

Mr. Neely would like staff to make sure the air conditioning is fixed or replaced where needed. He also spoke about a possible continuation program at Henderson School. He suggested having flashing banners on the Lodi USD website to help advertise available positions.

Mr. Porter spoke about a special education teacher at Lodi Middle, who helps with the hearing-impaired students. He questioned why the District does not have a trained sign language interpreter, more paraeducators, and he would like staff to look at restructuring from the ground up, instead of at the administrative level.

Mrs. Macfarlane spoke about her experience at the Bear Creek football game, how wonderful staff was, how well the concessions and event were run.
