Superintendent's Report

Dr. Washer acknowledged that the San Joaquin County Office of Education extended appreciation to the staff of McNair High School, including Jim Davis, Principal and Dory Gonzalez, Plant Supervisor for hosting the Science Olympiad competitions this year. They also thanked Dale Munsch, Director of Technology, for giving up two of his Saturdays to monitor the high school computer labs for the events that required computers. Dr. Washer announced that Westwood Elementary School received an award from the Healthy San Joaquin Collaborative. It was recognition of an elementary school that has implemented innovative strategies in their food and physical activity environment to improve the health of students.

Public Hearings

2016/17 Budget Adoption

President Freitas declared the Public Hearing "2016/17 Budget Adoption" open. Tim Hern, Associate Superintendent/CBO and Angel Murnan, Director of Budgets, presented the report. Some of the highlights of the report were: enrollment trends; multi-year projections; and budget summary key assumptions. No comments were forthcoming from the Board or members of the public. Spending Determination with Respect to Fiscal Year 2016/17 Monies Received from the Education Protection Account (EPA)

President Freitas declared the Public Hearing "Spending Determination with Respect to Fiscal Year 2016/17 Monies Received from the Education Protection Account (EPA)" open. Tim Hern, Associate Superintendent/CBO explained the use of the funds. No comments were forthcoming from the Board or members of the public. The Public Hearing was declared closed.

Local Control and Accountability Plan

President Freitas declared the Public Hearing "Local Control and Accountability Plan" open. Lisa Kotowski, Assistant Superintendent, Curriculum and Instruction, was available to answer questions.

Public Comments

Lisa Cisneros, Attorney and Director, Lesbian, Gay, Bisexual and Transgender (LGBT) Program, California Rural Legal Assistance, spoke regarding the goals of their program and how services can address the multiple risks faced by the LGBT (lesbian, gay, bisexual, and transgender) student population in our District. Such risk include lower academic performance, suicide risks, increased suspension and expulsion rates and more likelihood of students in this population facing harassment and bullying.

Monica Sousa, Community Worker, California Rural Legal Assistance, spoke regarding Local Control Accountability Plan funds being used to improve services to the most high need students, including English language learners, foster youths and LGBTQ students. She cited data from the 2013-2014 California Healthy Kids Survey that detailed the percentage of LGBTQ students in Lodi Unified School District.

Martha Snider, Teacher, Christa McAuliffe Middle School, shared that the 2nd Annual Summer Fun Contest has begun at Christa McAuliffe. She will be attending the ISTE (International Society for Technology in Education) conference in Denver and will share information via e-mail. She ended her comments by thanking the District for 27 years of teaching in Lodi Unified.

Comments from the Board

Mr. Neely commented on the Plaza Robles, Independence and Liberty High School graduations; noting the pride and excitement in the students and families in attendance. He asked Dr. Washer to look into the success of these programs and perhaps enlarge and/or improve these facilities.
