I. Co-Curricular Transportation (Privately-owned vehicles)

A. The following information and regulations pertain to the transportation of students in privately-owned vehicles, the insurance requirements and parental/guardian consent/agreement.

1. Regulations:

- a. Under no circumstances shall a passenger car be permitted to carry more than five (5) people in addition to the driver.
- b. Except for transportation by parents, no student may be transported to any district-sponsored or school-related activity in privately owned vehicles, including vehicles owned by district employees, unless evidence is furnished prior to any such trip that the owner has liability insurance policies in the amount of \$100,000 per person or \$300,000 per accident. Privately-owned vehicles with acceptable proof of the aforementioned insurance coverage must be driven by persons duly licensed in the State of California.
- c. Students may drive themselves to contests or activities where they are participating when the above regulations are met, and students may ride with other students to contests or activities where they are participating when the above regulations are met.
- d. A student must have a signed parental/guardian consent agreement granting permission for the student to be transported.
